UK – Office of the Traffic Commissioner to close Verify facility. It has been announced that "Soon you will not be able to use GOV.UK Verify to produce a signature in the Vehicle Operator Licensing service. You'll need to create a GOV.UK account instead."

UK - DVSA earned recognition scheme launches new TfL module. "DVSA's earned recognition scheme has launched a 'TfL' module which helps accredited operators bid for Transport for London contracts. UK – Beware fake copies of The Highway Code are being sold. DVSA is currently investigating and taking action against sellers of a fake version of The Highway Code. The errors in the fake versions could put road users at risk of breaking the law or could cause failure in both theory and practical tests. Look for these key differences:

Barcodes; the official copy has an ISBN number above its barcode.

On the fake version, the logos on the front cover are slightly pixellated.

With a remit to represent patient needs to decision-makers, Healthwatch has addressed the problems of patient transport, especially the significant minority that struggle to get to appointments. Healthwatch is lobbying on four issues:

- ) The NHS to always ask about transport support following hospital discharge, so people recovering from treatment have a way to get home.
- ) Ensure nobody is discharged from hospital at night unless transport can be arranged, so that patients aren't stranded.
- A review of the NHS Non-Emergency Patient Transport Services (NEPTS) national eligibility criteria, so that people with long-term conditions who are eligible can consistently use this vital service to get to recurring hospital appointments.
- ) Improvements to the Healthcare Travel Cost Scheme (HTCS), so that those who need financial support to access appointments are aware of this benefit and can be reimbursed as quickly as possible.

Amongst the challenges considered, Healthwatch notes that community transport has a "high demand for services".

Community Transport and Small Vehicle Operations – TAS Commentary

In the good / bad old days, s19 permits were restricted to small (9-16 seats) or large (17+ seats) buses. Some of the smaller minibus models could be procured with only 8 seats, mostly for the Private Hire market, but could not be used with a permit. Then in April 2009 this restriction was revised by DfT, which extended the scope of the s19 permit to additionally include vehicles with 8 or fewer passenger seats. These were designated in DfT guidance as "small vehicles - adapted to carry 8 or fewer passengers (excluding the driver)." There was, however, a significant caveat. Small vehicles were only permitted to charge 'separate fares', which had operational implications for many CTs. Additionally, the VAT provision that passenger transport with a driver was zero rated only applied to buses of 9 or more seats, which meant that any fare charges on a small vehicle would be subject to VAT at the prevaling rate.

4.4 Separate fares - "Separate fares mean an individual payment by each passenger to the driver or other representative of the permit holder for the journey undertaken. Payment may be made on the vehicle or in advance. It may also be by indirect means, perhaps in respect of other services (eg tickets to an event where travel is included), or as part of a regular subscription to an organisation. Separate fares are not paid where the vehicle is hired as a whole for a set charge (which isn't influenced by the number of passengers carried) and passengers, to the knowledge of the driver or permit holder, make no individual contribution."

The implication for CT operators is that small vehicles cannot be used as part of any group travel provision where a single, overall charge is made for use. In fact, the only circumstance where a group can be provided with a smaller vehicle is where the CT hires the vehicle only to the group (similar to a commercial van hire approach). In this situation, the hiring group is the operator – it needs to use its own s19 permit if charging the passengers, and its own insurance, and provide its own driver. Another option would



be for the small vehicle to operate under Private Hire (a permanent and potentially costly move), and any driver would then need to be licensed as a Private Hire driver – not so practical for multiple group usage.

The other implication for the CT sector is the inability to deploy small vehicles on local authority (or any other kind of) contract work, which intrinsically involve a single payment for usage. This can be a frustration as many contracts are structured to suit smaller vehicles with one or two passengers plus assistant, and CTs are faced with often having to operate larger and less economic minibuses on these kinds of run. In short, the use of s19 with small vehicles is restricted to services offered for individual passenger journeys, such as Dial-a-Ride or volunteer car schemes.

As a side issue, s22 permits have never been extended to include small vehicles, despite the fact that many routed rural services do not have peaks of demand that require more than 8 seats and in some areas vehicles with smaller physical dimensions than a minibus are more practicable on narrow lanes.

There is another, less well-known option: a PSV 'O' Licence holder can operate small vehicles as PSVs without requiring a Private Hire Vehicle licence – either:

- ) at separate fares and they must organise the journey and bring people together and the journey must be advertised to the general public. i.e. the agreement to pay separate fares must not have been organised by the passengers themselves or a third party OR
- ) not at separate fares, provided the use of a small vehicle must be only a small part of the operator's business of carrying passengers by motor vehicles. The understanding from DfT Guidance is that if under 10% of the fleet of vehicles licensed under a PSV 'O' licence are small vehicles the exemption may apply. However, as the legislation states, in defining "small part of the business" other factors such as mileage run or income may be taken into account. [This exemption is at s79A PPVA1981]

Neither of these options would be straightforward to implement.

Finally, there is an environmental consideration. One appeal of small vehicles using s19 at this point is the greater range of purchasing options and affordability for accessible EVs with up to 8 seats. This coincides with a more or less general decline of demand for door-to-door minibus services, a trend that actually predates COVID. Many traditional Dial-a-Ride-type services are continuing to operate 14 or 16-seat minibuses when the peak multi-occupancy is no more than four or five, and such vehicles are prohibitively expensive to upgrade to electric in a like-for-like manner. In may be that more small vehicles are deployed on these services in future years but at present the emphasis on small EVs is at odds with the permit legislation.
