UK – DfT Driving Licence Review.

Following last year's consultation, DfT has now published Call for evidence on opportunities for changes to the driver licensing regime – summary report.

This includes a section on D1:

"Consultees were asked if they would support the removal of the requirement to obtain a D1 licence test to drive a minibus. Of 2,052 who answered the question, most (73%) were supportive. This included three in ten (31%) who were supportive with additional stipulations. Around one in four (23%) were not supportive, while



one in twenty (5%) were unsure... Those who were supportive dependent upon additional stipulations were asked to indicate from a tick-list what those additional stipulations should be. Most of these consultees believed that there should be a minimum age requirement (86%). This was followed by around half (49%) who thought that there should be a mandatory requirement to undertake additional training such as MiDAS and two-fifths (41%) who believed that there should be compulsory medical requirements. Around three in ten (29%) believed that there should be compulsory conduct requirements

and/or requirements at renewal stage (also 29%). Around one in six (16%) thought that there should be another stipulation.

Those who were against D1 requirement removal were asked about their concerns. Of 461 consultees who answered the question, most (92%) raised safety concerns, three-fifths (61%) had concerns about poor driver skills and one-fifth (21%) indicated other concerns. Other concerns included worry about inexperience of younger drivers, impacts on driving standards and that it could be dangerous."

UK – HM Government Publishes "Unleashing Rural Opportunity" Report.

This new report outlines "four broad priorities that are key for rural areas to thrive. These are already being supported by many existing policies and this document underlines our commitment to further improving the quality of life for rural people by setting out additional initiatives we will undertake." The four priority areas are: Growing the rural economy; Connectivity; Homes and energy; and Communities. Under Connectivity, transport issues are covered with the following commitments:

"Publish a Future of Transport Rural Strategy setting out principles to support new innovative technologies in improving access to services, tackle isolation and increase access to jobs in rural and remote areas.

- Following our recent consultation [see item above], do further evidence-gathering on the entitlement for drivers who passed their car test to drive a light lorry or van (C1 entitlement) without the need for a separate test, just as anyone who received their licence prior to 1997 can already do. Our consultation showed 73% of respondents said they would support the removal of the requirement to obtain a D1 licence test to drive a minibus.
- Consult soon on reform of bus funding, including options to better support rural areas and stimulate new routes where there is little or no coverage."



West Sussex - New Booklet Celebrates 50 Years of the Harting Bus.



With 50 years of successful operations in the Hartings, providing links to Petersfield and Chichester, the Harting Minibus is one of the longest surviving community bus services in the country. Its history has now been recounted by Barry Mackay in 50 Years of the Harting Bus 1973-2023 - A Short History. It is particularly interesting to read how in the early years community activism and enthusiasm (along with the dire need for a bus service) was able to overcome many barriers in the pre-Permit era, and the fact that the bus subsisted for years without being able to charge any fares. Photos of the early operations using a Mk1 Ford Transit Crewbus (with side facing bench seats) show how far vehicles have improved. Barry

concludes: "I offer my heartfelt thanks to all those who went before for their hard work, commitment, foresight and, at times, stubbornness in founding and keeping such an enterprise going for half a century." Isle of Wight – Plea for Community Bus Service to be Extended. Writing on the Yahoo news group Derek Ashmore, of Sandown has commented that: "Over the past few weeks, we, at the holiday park and residents of Perowne Way, have had the great luxury of having a weekly bus service while the bridge at Lake Hill was repaired. Now, as the repairs have finished, we are back to relying (and don't get me wrong) on our community bus service, which is superbly driven by polite and exceptional people and the service is a lifeline to us. However, it only operates three times a week (Tuesday, Thursday and Friday) starting at Morrisons, Lake, at 9.45am, and the last bus back to Lake is 12.28pm from Sandown, which is no time at all. When Southern Vectis was approached on our behalf (by Cllr Paul Brading), the CEO was asked if it was possible to continue the service or one bus service when Lake Bridge was up

and running. His reply was that it was a matter of logistics. Well surely it could be implemented, as services 2, 3 and 8 were diverted down Perowne Way as the logistic problem (if there was one) was in operation during the work on the bridge. North Yorkshire – Little White Bus Praised in the Light of DRT Failure. Long-serving Wensleydale based CT Little White Bus has been referenced as a more sustainable model following the failure of the DRT Yorbus, which has been withdrawn on cost grounds. Suffolk – Closure of Boots' Stores Highlights Increasing Need for CT Services. With an issue that will be echoed in other parts of the UK, the impact of the proposed closure of 300 branches of Boots' on older residents is being considered in Suffolk. Ann Osborn, of charity the Rural Coffee Caravan said: "the more and more things disappear, the harder their closure is going to become and the more pressure on things like community transport and good neighbour schemes..." Northern I reland - Department for Infrastructure Budget Cuts Announced. Community Transport in NI has been threatened with major funding loss due to DfI cost-cutting measures in the wake of the need to mitigate against a £112m funding gap. Budget allocations have now been announced and involve the following:

- "Dial-a-Lift services and the Disability Action Transport Scheme will be funded from 1 August at 95% of the level allocated for April to July;
- Funding for the Assisted Rural Travel Scheme (ARTS) will continue at current levels;
- Community Transport provision for the longer term will be reviewed, to ensure that we are maximising both value for money and outcomes through these key services."

However, DfI is currently restricted due to the lack of a ministerial presence and has said that "it is recognised that some decisions that would need to be taken to live within budget allocations are not within the power of Senior Officials to take under the Northern Ireland (Executive Formation Etc.) Act 2022, amended by the Northern Ireland (Interim Arrangements) Act 2023 in the absence of an appropriate decision maker. Northern Ireland – Out & About CT Wins Lottery Grant. A very welcome £380,000 grant award has been made by the National Lottery Community Fund to Magherafelt-based Mid-Ulster Community Services to expand its Out & About Community Transport service. The funds will enable Out & About CT to expand its rural transport service to cover weekend and evening medical appointments and reduce their carbon footprint.

Scotland – Aberdeenshire Council Revises its Approach to Community Transport Grants. A revised approach to the Aberdeenshire Community Transport Initiative (ACTI) has now been agreed by councillors. Aberdeenshire Council reports that "under the measures, new organisations will be allowed to apply for grants from the 2024/25 financial year onwards. Councillors were provided with the findings of a review undertaken earlier this year into the process for awarding grants to community transport organisations under ACTI. While recognising that there is a risk that existing grant-holders could have their new applications rejected or grant funding reduced, given that it is expected that there will be no increase in budget, officers maintained that the proposal is in the interests of fairness and intended to stimulate development of new projects and services across the region. There is a large spread in the values of grants awarded for the 2023/24 financial year ranging from around £9,000 to £150,000 per annum. The two largest grants account for £300,000 in total which is approximately 74% of the budget. Under the agreed changes, the maximum grant which can now be requested by any organisation will be capped at 40% of the budget which currently stands at £396,000."



Scotland – Community Bus in Forres Seeks Rebrand. Operating since 1973, the Forres Osprey Bus has decided that a change of image is required. This is partly due to people thinking the bus is in some way connected with the Osprey bird. Members of the community have been approached to decide on options for the rebrand at the Highland Games. Chair Shaun Moat said "I've been stopped and asked about Osprey birds so many times! I regularly explain that the bus doesn't have anything to do with them but is for the folk of Forres! With the new bus almost ready for delivery, we think there is a great opportunity to re-brand and allow the community to come up with the new design and name." Scotland - Moray Council's m.connect Dial-a-Bus service in Healthcare Access Debate. The announcement of the closure of the Burghead and Hopeman branch GP surgeries has caused concerns around the use of the m.connect Dial-a-Bus service, and sudden demand to take patients to a GP further afield. "The council-run m.connect bus service was trialled as a solution to take patients from Burghead and Hopeman for appointments in Lossiemouth. But the buses are used for school transport. So operating hours are limited to 9.15am to 2.30pm Monday to Friday during term time." Local councillor Mrs Mustard "wants clarification over the purpose of the service and does not want it 'hijacked' for patient transport.... There are also concerns that a council service could be used to mitigate cuts being made by another organisation..."

fundraising power of secondhand bookshops has been well-proven by Oxfam, whose bookshops are now often the best in town. A similarly interesting enterprise is the Book End Bookshop in Bakewell, which has the sole purpose of generating funds for Bakewell & Eyam Community Transport. CT's operating retail projects often find that passengers are a ready source of stock donations and the ability for vehicles to collect items at people's homes makes for a very useful facility that many charity shops do not have.

Nottinghamshire – CT4N Adopts Living Wage Standard. Community transport operator CT4N has become the latest organisation to provide a real financial boost for its employees during the cost-of-living crisis after becoming an accredited Living Wage Employer. The not-for-profit bus firm has not only pledged to pay all its staff well above the statutory minimum wage, salaries even exceed the Living Wage Foundation's recommended £10.90 per hour. On becoming one of the latest of 13,000 employers to sign up to the Living Wage campaign, I an Combellack, CT4N Managing Director, explained: "We recognise that our workforce is our most valuable asset, and it's only fair they should be paid appropriately for all their hard work and professionalism. As a result, all our employees receive at least £11.13 an hour, and we're sure this commitment to fair pay will help us to retain and reward colleagues, while

helping us find new recruits for our friendly and diverse team. This will be vital as we look to achieve our mission to provide a range of transport solutions to reduce social isolation and promote community cohesion across Nottingham and Nottinghamshire." In addition to the Living Wage, CT4N offers a host of employee benefits, including a generous holiday allowance and a long-service award scheme that includes



additional leave. Employees can also take advantage of a cycle-to-work

initiative and private healthcare, as well as participation in a scheme that offers discounts on a range of electrical goods. It's currently recruiting drivers for its community services, as well as commercial operations that support its charitable work. Essex – Tiptree Residents Call for Community Bus Service. Trustee Recruitment & Community Transport by John Atkins

Trustees seem to be in short supply. All voluntary sector CT operators are required to maintain a functioning management board but this is often easier said than done. Depending on governing documents and constitution, this board might be referred to as directors, committee members, board members, or trustees. They have the same function and legal status whatever term is used, and are here referred to simply as 'trustees'.

Whilst I'm not sure that there was ever a rose-tinted era in the CT sector when trustees were plentiful, skilled, focussed and enthusiastic, there is certainly a current challenge that has been growing over the last few years in that many CT operators are struggling to maintain a management board, both in terms of overall numbers and requisite skills and experience. There is evidence that this is a problem in the wider voluntary sector, though some charities do better than others. Engaging younger trustees is especially difficult: managing a community transport service is a hard sell to many under 30s!



Recruiting trustees is one area that is somewhat outside the bounds of management control, and cannot be 'bought in'. There is also a somewhat fluid definition of trustees' roles and a degree of uncertainty around a number of key issues such as:

- Are we guorate at the AGM?
- How many trustees should we have? (Governing documents usually set a legal minimum of 2 and a practical maximum that might be as many as 15)
- What is the best balance of skills and experience?
- Should our trustees be drawn from our users or from wider stakeholders?
- Should we rotate the chair position?
-) Should there be a succession plan?
- I Should we have local councillors on the board?

It is difficult to answer these questions as circumstances differ widely. On the question of how many trustees make for a stable, diverse and functioning

board, it is possible to look at a cross section of CT operators based on the data they have submitted to the Charity Commission. The table below presents data from a sample of 50 CT operators of different kinds from all corners of the UK and can be viewed as a snapshot of the CT sector based on last year's returns.

The data above has been selected to enable any correlation or trends to be noted around location (are trustee levels higher in some parts of the country than others?) and income levels (do the bigger operations enjoy a fuller compliment at board level?). However, the sample indicates no such trends — the lack of trustees is a problem in all areas and affects operators irrespective of scale. The broad question that does emerge, however, is whether an average of five trustees is adequate. For many projects, especially the bigger ones, I would suggest not. Many CTs are actively trying to recruit new trustees and find it extremely difficult.

A few suggested approaches that might be useful are:

- Juse of volunteer centres and the 'Do-It' website;
- Package trustee positions as being short term (12 months) and avoid the implication of longer term commitment;
- Use social media and informal networks;
- Headhunt approach trustees who are already working for another charity and see if they are interested in a second role (many trustees sit on more than one charitable board) in general be proactive and engage with potential trustees and don't wait for them to come to you; and finally:

Ensure your board structure, responsibilities and roles are clearly set out and readily communicable to those outside of your organisation.
