UK – Government Disability Action Plan Consultation. The government has launched an open consultation on its proposed Disability Action Plan: "We are seeking views on the proposed Disability Action Plan and the new areas for action it includes. We want to hear from as many people as possible. This consultation closes at 11:59pm on 6 October 2023." Under the section 'Government Plans for 2023-2024', DfT lists proposed measures for rail, taxi, private hire, buses and coaches but makes no reference to community transport. Likewise, proposed actions by the Disability Unit – apart from a few mentions of general accessibility improvements – do not include any transport related measures at all.

UK – Parliament Transport Committee Call for Evidence. "The Transport Committee is inquiring into how the Government sets its strategic transport objectives and how these objectives do—or should—influence decisions on investment in, and cross-government planning of, services, networks and infrastructure. "Future investment planning is currently mostly done on the basis of individual transport modes or specific programmes, with bodies in different parts of the country advocating new infrastructure, revenue funding or powers to support and improve services across all modes in their area. Funding in some modes is both short-term and in short supply, with resources often allocated by competition. The Institution of Civil Engineers and the National Infrastructure Commission are among organisations who have recently set out the case for a strategic transport vision at a national level to guide policy and investment decisions. We want to investigate the extent to which the Government takes a long-term, national and multi-modal approach to predicting, providing for, maintaining and developing the country's transport needs, and what difference adoption of clear, national strategic objectives for transport could make. We welcome submissions of written evidence that address any or all of the following themes. We are also interested in receiving submissions that draw on international comparisons to address these questions." <u>https://committees.parliament.uk/call-for-evidence/3175</u>

UK – Blue Badge Misuse Warning. A recent case in Reading in which a care home manager misused an organisational blue badge resulted in the individual being handed a £7,000 fine. This should serve to remind any CT operators of the potential consequences of orgnisational badge misuse.

UK – Take the Bus Campaign Encourages Older People to Make the Most of Free Bus Travel. DfT has launched a new campaign to encourage passholders to use the bus this summer. DfT announcement summary:

-) "new campaign launched to encourage older people to use their free bus pass to meet friends and family, rediscover local attractions and get their 'culture fix from 66';
-) drive to increase bus travel will boost wellbeing of older and disabled people, support sustainable bus services and help grow the economy;
-) latest statistics show a 36% drop in bus usage since 2019 for concessionary passholders, sparking move to encourage eligible people to get out and about for free."

UK – Reporting Bus Fires. DVSA and the Traffic Commissioner have recently investigated instances of bus fires and have emphasised to operators the need for correct maintainence and the requiremet to notify DVSA of serious incidents (England, Scotland and Wales only). UK – CTA National Conference & Awards Event 23 Nov 2023. In a return

UK – ATCO Guidance on Use of Seat Belt Buckle Guards. Following the recent debates on the use of buckle guards,

the Association of Transport Coordinating Officers has published a guidance document Good Practice Guide for Local Authorities regarding Alternatives to Seatbelt Buckle Guards. ATCO says it has been "working with the DfE, DfT and DVSA." This document does not, as happened with the previous communication from the DVSA, give a date when we should stop using the Buckle Guards but does set out the reasoning why we need to move to a position where we all stop using them. There are also examples of alternative practices tried by some councils to reduce or cease their use." The document is available to ATCO members – CT operators who are not members may be able to obtain a copy from their local council transport contact.





-) HCC Budget Consultation CTA has responded to a consultation by the Hampshire County Council on why funding for CT must not be discontinued.
-) Clean Air Zone Clarification CTA has had clarification from Portsmouth City Council that a CT M2 class vehicle operating under a Section 19 or Section 22 permit will not be subject to charges for failing to meet emission standards in the clean air zone.
-) BSOG Fuel Allowance Uplift The Department for Transport is currently reviewing the administrative requirements for CT providers to ensure the process is proportionate to the level of support being provided. Once this is finalised, the uplifted fuel allowance rate will be available to CT providers.
- J State of the Sector Much has changed since the last England-wide State of the CT sector research was published in 2014. In the autumn of 2023, CTA will begin research to provide a thorough and up-to-date overview of the sector in England, which will build on similar work conducted in Scotland and Wales to ensure harmony of data whenever possible. Nottinghamshire – CT4N Receives Welcome Donation from Car Rental Company. Enterprise Rent-A-Car, which has four outlets in and around Nottingham, has shown its commitment to reducing social isolation and increasing access to transport with a donation via its philanthropic arm to the CT4N Charitable Trust, which provides not-for-profit transport services helping elderly people and people with mobility issues to get out and about, And CT4N Managing Director I an Combellack said he was delighted to receive a cheque for £2,000 in support of their work from the Enterprise Holdings Foundation.

Enterprise provides a car and van hire service from its Nottingham and Ilkeston outlets part of its UK wide network of more than 450 branches. "This donation is a marvellous boost for us in helping us to continue our work in providing services to counter loneliness and isolation," said Ian. "We are very grateful to the Enterprise Holdings Foundation for their support, and it's so encouraging that they recognise the value of what we do for the community." The Foundation was established in 1982 "to give back to the communities where our customers and employees live and work."

Devon – Dawlish CT Vehicles in Arson Attack. A devastating arson attack in Dawlish on 14 July has destroyed six minibuses belonging to Dawlish

Community Transport, with a seventh vehicle also likley to be written off. Det Sgt Martin Key said: "These minibuses belong to the local community transport and are vital to the community. This is an appalling act of vandalism and we are doing all we can to locate and arrest the person responsible." The damage is estimated to be around £280,000 and police have released CCTV image of a man at the scene whom they wish to interview. Undaunted, Dawlish CT were back in operation after a couple of days.

Devon – Go North Devon Service to be Rescued. It has been announced that Go North Devon Ltd would cease operations completely at the end of September 2023. However, its North Devon Ring and Ride Service will now pass to another operator Mid Devon Mobility, who have pledged to keep the Ring and Ride service in place. Chief Executive of Mid Devon Mobility Faye Ashton, said: "We are very aware of how vitally important the Ring and Ride Service is to the people it serves, as without it many older and disabled people would be unable to leave their house and access local shops and facilities. Many of our customers regularly tell us how the Ring and Ride and The Day Trip Club is their only means of getting out and about and the social aspect is extremely important to them. Devon – OurBus Services Threatened in Torbay Unless Volunteers can be Found. Torquay-based OurBus has struggled to meet its commitment to operate its routes 61 and 65 with only four volunteer drivers, and has reduced the level of service until it can double its driver roster. Co-ordinator Kelly Bedoyan said: "Our drivers love doing what they do and their passengers are very appreciative. But for some reason, we are struggling to find them at the moment...The passengers and volunteer drivers who are part of OurBus know that it provides more than just a bus service; it's a community centre on wheels where neighbours can meet, share news, find out more about what's going on in their area and maybe even become friends..." Yorkshire – 40 Years of Scarborough Dial-a-Ride. One of Yorkshire's longest-serving CT operations, Scarborough Dial-a-Ride, celebrated its 40th birthday with a party at Sawdon Village Hall. The service commenced in 1983 with two secondhand minibuses. Manager Tim Lawson said: "without our wonderful drivers, passenger assistants and office support, we would not be

able to provide our essential transport services to older people and those with disabilities. They all go above and beyond and this event was a small way of saying Thank You to everyone who has been involved over the past years. Dial A Ride has continued to go from strength to strength but only because of the people involved". New volunteer minibus and car drivers and passenger assistants are being sought. Scotland – Orkney CT Services are Funded. Orkney Islands Council have announced the following: "Community transport solutions - including three totally new initiatives - have been granted up to £44,000 funding by Orkney Islands Council to improve connectivity in some of our most fragile communities. A total of eight eligible bids for funding were received by the Council's Transportation service, following promotion of the Community Transport Small Grants Scheme for funding of up to £10,000 per project. OIC's Transportation Service Manager, Laura Cromarty, said: 'This was a great response and we're delighted to see three new isles projects in the mix for 2023-24. We reviewed our Community Transport Grant scheme last year, which resulted in the creation of a small grants scheme with a simplified application and approval process.'

The funding awarded will enable the continuation of a community transport service in Hoy with an extended service to connect with the Moaness ferry (I sland of Hoy Development Trust), and the continued operation of the out of hours ferry for Shapinsay (Shapinsay Development Trust) and Papa Westray (Papay Development Trust) for social and leisure activities. Newly established community transport services in Rousay, Stronsay and North Ronaldsay (through Rousay, Egilsay and Wyre Development Trust; Stronsay Development Trust; and North Ronaldsay Trust respectively) have also been awarded funding. Continued funding has also been awarded to Dial a Bus for door to door transport services across mainland Orkney from the large grant scheme. Additional funding during 2023/24 will be provided to enhance this valued service further.

The number of eligible projects well exceeded the community transport budget available. Match funding for the projects has come from the Council's Sustainable and Green Transport Fund to help make up the shortfall – a pot fed by ticket income from the Council's subsidised public bus services and earmarked for improvements to local transport such as additional services, bus shelters and community transport projects. Councillor David Dawson is Chair of OIC's Development and Infrastructure Committee: 'Our Transportation team works hard to try and support communities where standard public transport services are just not feasible – so this is a gratifying result for the Council and communities and I wish each of these projects the very best.'" https://www.orkney.gov.uk/News?postid=7836

Scotland – CT Project in North West Sutherland is Shelved. Greater London – Ealing CT and 'This Better Transport Week'. In June

Transport for London has awarded a multi-year contract to tech developers Via, with the aim of improving "accessible transport across the city through technology. As a result of a competitive two-year tender process, Via will introduce its software platform in early 2024, powering the Dial-a-Ride service with the aim to further increase the quality of service and passenger experience for elderly and disabled members in London. The partnership will also help TfL to expand the Dial-a-Ride service to reach even more people. The announcement is a milestone in the adoption of technology-enabled accessible transport solutions in the UK. TfL's Dial-a-Ride, with Via's software, will serve as a blueprint for other cities and transport authorities across Europe to make public transport more inclusive, efficient, and cost-efficient at scale...The new software will benefit Dial-a-Ride's 30,000 members helping TfL to provide customers with reliable and equal access to transport for everyday leisure trips that are so important to maintain a high quality of life."

Greater London – TfL ULEZ Minibus Scrappage Scheme. Transport for London has been reminding vehicle owners of the Ultra Low Emission Zone (ULEZ) standards that will apply across all London Boroughs from 29 August 2023. For charities operating minibuses, it has offerred a scrappage scheme: "We are increasing the grant payments to scrap or retrofit a non-compliant van or a minibus. Successful applicants can now get £7,000 to scrap a van, £9,000 to scrap a minibus, £6,000 to retrofit a van or minibus, £9,500 to scrap a van and replace with an electric van and £11,500 to scrap and replace a minibus with an electric minibus. This increased payment will be available from 4 August 2023 for all new applicants and those who have applied but not yet submitted evidence of scrap or retrofit.

Charities operating in London can apply to scrap or retrofit up to 3 vans or minibuses, and may reapply even if they already received a grant payment for one vehicle as part of this scrappage scheme or received a grant through the previous scrappage scheme. From 21 August 2023, eligible businesses and sole traders will also be able to apply for up to 3 vans or minibuses in total, even if they had received a grant payment for one vehicle as part of this scheme." <u>https://tfl.gov.uk/modes/driving/ultra-low-emission-</u> <u>zone/scrappage-schemes/van-minibus</u>. However, CT operators can enjoy a full discount on ULEZ charges for another year: "Many not-for-profit organisations that operate minibuses used for community transport can register for a temporary 100% discount of the ULEZ charge until 26 October 2025. These are minibuses that carry passengers on a not-for-profit basis. For example, for educational, religious, social welfare reasons, or other activities that benefit the community..." <u>https://tfl.gov.uk/modes/driving/ultra-low-emission-</u> zone/discounts-and-exemptions#on-this-page-4 Berkshire – ReadiBus has 'Gagging Clause' Removed. CT operator ReadiBus has announced that it is no longer constrained by a West Berkshire Council contract clause which disallowed them to "make any press announcement or publicise the agreement or any part of the agreement in any way, except with the prior written consent of the council." The Council has now agreed to remove the clause from future contracts.

Berkshire – Reading Councillor and Founder of Readibus Receives Honorary Degree. Councillor Tony Page's 50 years of public service was recognised with an honorary degree from the University of Reading. As well as being a Labour councillor and former Mayor, Tony has developed "better public transport for the people of Reading" and was "instrumental in establishing ReadiBus, the UK's first dial-a-ride community transport service in the 1970s, which still serves the town today."

Suffolk – Volunteer Drivers Required for CT Service in Haverhill Area. The community transport service provided by The Voluntary Network is seeking volunteers for its Connecting Communities project, involving both minibuses and cars. Managing Director Caroline Robinson said: "Certainly a lack of volunteers does impact upon the service. We are increasingly having to decline local groups which is really frustrating. They invariably have no affordable alternative. Passengers are still rebuilding confidence and connections after Covid. Lockdown has had a longer-lasting impact upon some, facing a significant change to their mobility and confidence. The last thing we want is for a lack of transport to be the barrier."


