UK – DVSA Announces that New Return to Professional Driving Courses are Now Available. DVSA: "Reforms to Driver Certificate of Professional Competence (CPC) were passed by UK Parliament and came into force on 1 February 2025. One reform allows people whose Driver CPC has expired for at least 60 days, but no more than two years ago, to return to professional driving by undertaking a seven-hour return to driving course..

New courses are available: Completion of the return to driving course will allow drivers whose qualification has run out in the last two years to be able to return to driving with a National Driver CPC. They must then complete the remaining 28 hours of training within the next twelve months in order to receive a card with the remaining four year's validity. UK – Toyota EV Loan Scheme. Toyota GB has launched a new community programme to loan electric vehicles to various charities and educational institutions across the UK. For a two year period, qualifying organisations can have use of a Proace Verso Shuttle people carrier, in order for them to transition towards an electric fleet. 42 of the vehicles will placed on community



loan. Toyota is also providing a £1,000 grant towards the purchase of a wall box charger. The first vehicles have been allocated to Surrey Wildlife Trust and Power Up (Nottingham), which promotes and enhances the physical and mental wellbeing of young people and adults including refugees, individuals with disabilities and marginalised groups, through sport and fitness. <u>https://fleetworld.co.uk/toyota-opens-ev-loan-scheme-for-community-fleets/</u>

UK – New Electric Minibus Launched in UK by Karsan. Innovative Turkey-based vehicle manufacturer Karsan has launched a right-hand drive variant on its "small city bus" the e-JEST. Designed for narrow streets, the low-floor bus has a range of 210 km and can accommodate up to 22 passengers.

GB – Route One Reports on Permit Issue Trends. DfT began publishing weekly data on Office of the Traffic Commissioner permit issues from January 2024. Route One has commented that "The number of current Section 19 standard permits issued...fell between January 2024 and the same month in 2025, but permit volumes of Section 19 large bus and Section 22 authorisations rose over that period, data published by the TCs has shown. In mid-January 2024, there were 16,857 TC-issued Section 19 standard permits in circulation via 6,498 applications. As of the first day of 2025, those totals were 15,791 and 6,032 respectively. That represented a decline of 6.3% in the overall number although the following week's figures showed a slight uptick. England – Integrated National Transport Strategy: a Call for I deas. The DfT is developing a strategy which will set the high-level direction for how transport should be designed, built and operated in England over the next ten years. It will set out a single national vision which will:

- $\int$  put people who use transport and their needs at its heart and
- ) empower local leaders to deliver integrated transport solutions that meet the needs of their local communities...

To help it create the strategy, it is now asking people:

- ) about their experience of transport in England
- ) what it could do to make it better
- It wants to hear from:
- ) people who use any form of transport, including cars, vans, motorbikes, mopeds, trains, underground, metro, trams, buses, minibuses, coaches, bikes, e-bikes, walking or wheeling;
- frontline transport workers people who work in the transport industry and
  companies and organisations that operate in the transport sector

West Sussex – Hyde Community Bus Launched. A new bus service has been put into operation by a partnership between Hyde (Housing Association), Rivervale (vehicle retailers), and Community Transport Sussex. The Hyde Community Bus Project was launched in December



and "will address key barriers by providing a vital link to essential services, social activities, and activities to aid better mental health for residents of rural north Chichester." By providing accessible transport, we are helping to break down barriers to mobility

Surrey – CT NEPTS Service is Curtailed in Frimley. Maidenheadbased CT operator People to Places has been forced to reduce its nonemergency patient transport service following Frimley Integrated Care Board opting to 'buy' fewer hours from the CT. The operator, which recently won a local Community Project of the Year 2024 Award, claims this will create uncertainty and barriers for passengers and put drivers at risk of having no work. The EMED Care Group has apparently been engaged by the Care Board to provide NEPTS services.

With 25 years of valued operations behind it, North Norfolk Community Transport has now added its first zero-emission vehicle to the fleet, which is based in North Walsham. Chair Nigel Lloyd commented: "I wish to offer my sincere thanks to all the organisations that have helped us add a brand new vehicle to



our fleet. One of our strategic aims as a charity is to reduce the carbon footprint of our activities. I am therefore delighted that we have been able replace a diesel-powered vehicle with a brand new zero emission vehicle, especially as we celebrate our 25th anniversary year of serving

Shropshire - The Friendly Bus Receives Funding to Support Community Transport Services. A £7,000 grant has been awarded to Shropshire-based CT The Friendly Bus by the VINCI UK Foundation in

support of its services in Broseley, Much Wenlock and surrounding areas. The grant "will contribute to The Friendly Bus's 'Buy-a-Bus' campaign, which aims to purchase a fully accessible 16-seater minibus to meet the growing demand for its services. Currently, The Friendly Bus supports over 800 registered passengers, ensuring they can remain independent and socially connected." Chief Executive Officer of The Friendly



Bus Marie Monk-Hawksworth commented: "We are really grateful...for this grant. It has made a substantial contribution to our 'buy a bus' campaign, which hopes to replace two, possibly three of our old minibuses. Having driven to many clubs, social outings or shopping trips, they're now costing us vast amounts in breakdowns and repairs – leaving some of our passengers without any way of getting out and about when they are off the road."

Essex – Community 360 Closes Colchester Hub. Essex CT operator Community 360 has temporarily closed its Colchester base for a few months. The organisation offers Shopmobility and voluntary sector support as well as community transport. Cris Huddleston, Chief Executive, said: "In recent months, Community360 has faced challenges that have prompted a serious and necessary re-evaluation of its business model, operations, and priorities. We believe that this review will result in positive long-term changes



for the organisation and the community we serve. Greater London – Community Transport Waltham Forest's Big Reveal Event! Somerset – Wivey Link Supports Restoration of Bus Service. Wivey Link CT has supported a campaign to restore a bus service between Wiveliscombe and Wellington, despite fears that its car service would suffer if buses again ran between the two towns. A Wivey Link spokesperson said: "Our view would be to support a Wivey-Wellington bus service. Hertfordshire – Sawbobus Trials Route with Station Link. A two-week trial has been held to enable rail users to get to Sawbridgeworth station to meet a number of early morning London services, with late afternoon return runs The bus is operated by Sawbridgeworth Town Council and the trial is designed to test demand and timings. The Sawbobus community transport scheme was set up in November 2009 by former town clerk Richard Bowran. Northern Ireland – John O'Dowd Reflects on His First Year as Infrastructure Minister. After an uncertain time in the NI CT sector, Infrastructure Minister John O'Dowd has reiterated his support for CT in a statement following his twelve months in office: "I have ensured that public transport is affordable and I have protected concessionary fares. I have also made sure that the delivery of community transport, which is such a vital service for many, is protected by providing a 4.2% increase to support staff costs. Transport plans are taking shape with Eastern, Fermanagh and Omagh and the North West Transport plans at various stages of development. Dorset – End of Road for NORDCAT. Sturminster Newton-based CT operator North Dorset Community Accessible Transport (NORDCAT) has announced that it will close down from mid-February. It cites financial difficulties as the main reason and several members of staff (general manager, admin officer, four drivers) are now redundant. It is suggested that 100 current active users of its door-to-door service will be affected from a total of 800, as well as organisations who used its group transport service. Chairman ClIr Pauline Batstone said: "We bitterly regret the abrupt withdrawal of this service which has been a social lifeline to so many over the years. People have become friends with our staff and other passengers. There are other charities out there operating similar services and hopefully they may be able to move into the void left by NORDCAT." It would appear that the operator has not

been able to survive the loss of several home to school contracts which supported its core CT services. In 2023 the Traffic Commissioner mounted an inquiry and concluded that NORDCAT did "not have the competence or capability" to maintain its vehicles after an inspection found a 76% MOT failure rate. Any residual assets are to go to the car scheme operated by Community





## Scotland - National Rural and Islands Mobility Plan (RIMP).



The draft plan has been developed by Scottish Rural and I slands Transport Community (SRITC) which says that "the RIMP project is inspired by the fact that Scotland does not have an integrated national plan for rural and island transport, and a recognition that the development and implementation of one will create better outcomes for the people who live in these communities. This 12 month project that runs from April 2024 to March 2025 and will produce interim and final reports that set out the framework for the development of a plan that is formally adopted by the Scottish Government." RIMP is now at its Stage 4 phase (January to March 2025) which involves the "Development of Final Report and RIMP Framework for formal consultation...We are excited to

announce that the draft report summarising the findings from the first stage of the RIMP project is now available to review (<u>https://ruralmobility.scot/images/RIMP\_Stage\_1\_Report\_Final.pdf</u>.) Scotland – Cash Boost for Kilbarchan Bus Service. A £10,000 funding boost has been awarded to Johnstone and Area Community

Transport in Renfrewshire by the local council's Economy and Regeneration Board. The funds are to enhance a service for Kilbarchan residents to get to Johnstone, possibly extending into providing evening services. Councillor Andy Doig said: "Last year, along with other ward cllrs, I described John McBarron, the leading light behind the Johnstone and Area Community Transport bus initiative, as the hero of the hour. The big gap in bus transport .. is no evening bus service either in or out of Kilbarchan. This effectively means for non-car owners, and those on fixed



or low incomes, that they are essentially trapped in the village at night. I am hopeful that the £10K cash boost for John McBarron and his team, to recruit an additional driver, may mean that we are seeing the first steps to a night-time bus service for Kilbarchan." <u>https://www.the-</u>
